



BUFFALO COUNCIL ON WORLD AFFAIRS

Are you interested in United States foreign policy, international issues, and world affairs? Through lectures, seminars, discussion groups, and publications, the Buffalo Council on World Affairs offers broader knowledge of domestic and international matters. The Council is the "only organization in Western New York devoted exclusively to arousing community interest in international affairs. It is nonprofit, nonpolitical, and non-partisan. Its only goal is citizen education."

The Council offers a variety of programs during the year. On September 24, the annual Citation Dinner was held at the Buffalo Hilton. The speaker was the Honorable William G. Davis, Premier of Ontario, and the honoree was John Koessler, Jr.

Five o'clock Sherry Receptions are informal gatherings which give members the opportunity to question the speaker before or after the 5:30 p.m. talk. Meetings of this type are scheduled for November, January, and March. The Town/Gown Seminars, a series of luncheons held to help fulfill the need for business and academic people to become better acquainted with each others' views and areas of expertise, are scheduled for October, December, February, and April this year.

October through December, the Council emphasizes the sale of UNICEF holiday season cards, note paper, calendars, books, puzzles, etc. UNICEF was originally created in 1946 to provide massive emergency relief to destitute young victims of World War II. In 1953 the UN General Assembly extended UNICEF's mandate indefinitely. The words International and Emergency were officially dropped, but the initials had become too familiar to change. The Fund, over the years, has focused attention on the pressing needs of millions of deprived children throughout the developing countries. UNICEF cards began in 1949 when a seven-year-old girl made a painting for UNICEF in thanks for the help it gave to her war-ravaged village in Czechoslovakia. Her design became the first UNICEF card. UNICEF received the Nobel Peace Prize in 1965 for its work on behalf of children. This year's selection, especially attractive, will be available at some of the Branch meetings. Proceeds from the sale of one box of cards will buy enough vaccine to immunize twenty children against polio.

In January the 31st Great Decisions program will be launched with a Kick-Off Luncheon. Citizens meet in small groups to discuss eight carefully selected foreign policy questions of critical interest to the United States. This program is the largest foreign policy educational program of its kind with more than 150,000 participants. A Model UN Security Council will be held in December and a Model UN Assembly in March. The International Forum Group meets the third Wednesday in homes and will study Africa this year. Monthly television programs are presented (check your paper for times), and the Annual Dinner Meeting will be in June. PUBLIC SUPPORT FOR PUBLIC EDUCATION

The Public Support for Public Education has two goals. This year's priority is Goal II: school funding. The focus of Goal II is to assess funding sources, to evaluate the adequacy and equity of public school funding, and to promote public understanding and work with others for positive change.

Each AAUW member resides in a school district. Thus, our newest issue provides us with an opportunity for community involvement. In light of this, each member is encouraged to consider the following questions:

1. How and by whom is your local budget prepared?
2. What sources of revenue fund the school budget?
3. How much leeway does your district have in funding money and determining policies?
4. How have demographics of your community changed in the last decade?
5. How will the latest mandated school reforms be financed within your district?

Attend school board meetings. Become informed on your school district's budget process and even participate. It is imperative for the public to respond. As stated in the Carnegie Foundation Report: "Schools can rise no higher than the communities that surround them."

LEGISLATIVE PROGRAM



AAUW, as part of the Women's Vote Project, has invested many womanhours registering voters at the Erie County Fair and other sites in WNY. By the end of August, it was estimated that more than 2,000 persons had been registered and plans were underway to continue registering voters throughout September.

The month of October must be spent educating ourselves and others on the candidates and the issues. The League of Women Voters has information available on request. Call the local offices of our elected officials and ask their assistance in obtaining voting records and clarification of candidates' stances on issues.

Our work will not have ended after the election hoopla. We must hold those elected accountable for all their pre-election promises. The name of the game in politics is to get elected and then re-elected. It is our obligation to inform our representatives of our needs so they can make appropriate decisions. This can be done by letter writing, by sending telegrams, or by direct in-person lobbying. I highly recommend that each person get to know her representatives. By making appointments with the local offices and going in a group, one can make the system more responsive.

One way to become involved on a local level might be to take part in the Buffalo and Erie County Coalition of Government Observers. Watch for reports by this group on the County budget problems. If you would like more information on this group, call me at 627-9825.

ERA FACTS

part one

Through the year we will be presenting a series of points regarding ERA which we hope will be enlightening.


1. WHAT IS THE NYS ERA?

The Equal Rights Amendment is a provision which would be added to our NYS Constitution. It would provide: "Equality of rights under the law shall not be denied or abridged by the State of New York or any subdivision thereof on account of sex." Sixteen states have already added an ERA to their state constitutions: Alaska, Colorado, Connecticut, Hawaii, Illinois, Maryland, Massachusetts, Montana, New Hampshire, New Mexico, Pennsylvania, Texas, Utah, Virginia, Washington, and Wyoming.

2. WHAT WOULD AN ERA DO?

The ERA would, for the first time, establish an overall state policy requiring that, in the eyes of the law, individuals be judged as individuals rather than on the basis of the stereotypical presumptions about men and women which have traditionally limited people's options and their ability to develop fully as citizens.

The goal of the ERA is to make sure that the government does not deny people rights or opportunities on account of their sex. It would guarantee that all individuals receive fair and equal treatment under the law, regardless of sex.
