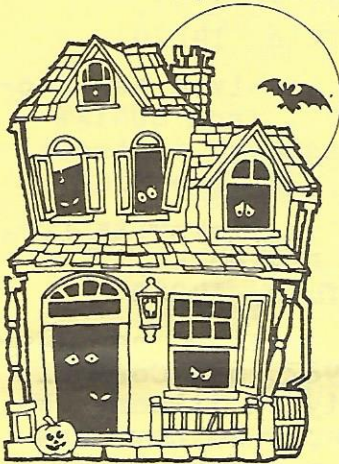

PRESIDENT'S MESSAGE

BARBARA CARRIER

Our AAUW year of activities is into full swing, and I hope that you're planning to participate in some of them! We have many members who could become your good friends, if you will but take the time to attend a meeting and speak to those whom you don't know already. Good fellowship is the reason given most often for membership in AAUW.

AAUW is quite concerned about the nomination of Judge Robert Bork to the Supreme Court. Please take the time to call or write Senators Moynihan and D'Amato to express your opposition. Bork's record demonstrates his support for severe limits on the "equal protection" guarantee of the 14th Amendment. In the absence of an Equal Rights Amendment, the legal rights of American women depend largely upon congressional action and the Court's interpretation of the 14th Amendment. One in five Supreme Court nominees have been rejected in the past on ideological grounds, so don't believe the arguments that it's useless to oppose him, that he can't be defeated.

District I of New York State Division is the Western New York area. The branches of that district are planning to meet in Batavia on Sat., Oct. 31, 1987, for a program to which all members are invited. The keynote speaker will be Loren Penman, and the topic is "Competing in a Man's World." A videotape on censorship will be viewed and discussed, and later there will be a panel discussion on "Individual Liberties Vs. Community Protection." Registration for the day is \$9 and the catered luncheon is \$6. If you are interested, please speak to any Board member or call me. I expect we will have quite a few attending.

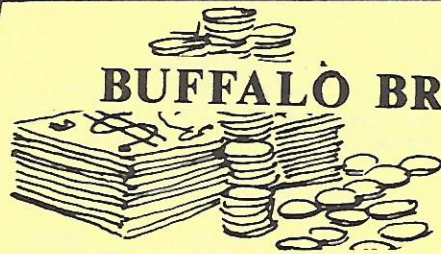

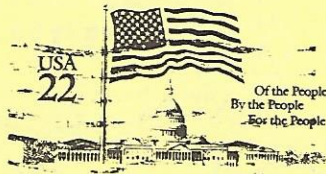

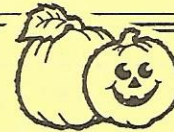
