

"Article VII Officers add a new section ----

 - 3. add in the absence of a co-president"

RATIONALE:

Allowing this option to the nominating committee would facilitate the candidate search process.



WOMEN'S ISSUES

The Women's Issues Study Group was struck by the very poor representation of women in the governing groups of all kinds of organizations, many of which include us! We urge everyone to consider the following:

- 1. How many women are on the board of the company in which you stock? Remember, board membership entails significant power to direct the course of a whole company and the lives of hundreds of employees, its national and international policies, etc. It also secures money and other perks to board members. Let's work for greater representation! The next time you have any correspondence with your company, such as at annual meeting time, note on your proxy card and write a letter to the CEO about including more women on the Board of Directors.
- 2. Similarly, how many women are on the boards of the art galleries, zoo, philharmonic, and many other organizations who apply to you for contributions, at least annually if not more often? Remember, policies re artists to be represented, salaries and working conditions of employees, priorities of types of services to be offered to the public, come out of board decisions. We are at least 50% of the public, and probably a higher per cent of contributors! When that next plea for funds arrives, pen a letter demanding greater representation of women on the board!
- 3. The same principle holds for all the organizations you belong to, pay dues to, maybe even give volunteer time to make sure that women are represented among the decision-makers.

CHOICES FOR TOMORROWS WOMEN

Future choices for women covers a wide territory of learning opportunities. A suggested starting point is that we could offer the larger community a workshop with speakers on various issues of concern to working single parents. In response to what we learn from the workshop participants we could offer a follow-up group session by a trained group counsellor who would be skilled in helping those who want to make career changes or plan to return for further education.

Another possibility is a study group of one year's duration that would meet four or five times to learn more about how our government really operates and how we can more fully participate in it. Some sessions would include a speaker.
