Since the confirmation of Clarence Thomas to the Supreme Court, we have heard a great deal about sexual harassment. Unfortunately, very few of us really understand the many forms sexual harassment takes. Among other things, it is an issue of power not sex, and is a part of the continuum of violence against women.

Ms. Avner and her task force have spent the past year holding public meetings around the state and collecting pertinent data. The task force's report will be released in January. Professor Finley an expert on issues concerning the law and women, will discuss sexual harassment and instances of sex inequity as legal issues.

## DECEMBER BOARD MEETING

The board meeting of the AAUW Buffalo Branch was called to order at 7:15 pm by Carolyn Day, president, at the Benjamin Franklin Middle School.

Minutes were read from the last newsletter and corrected. Jill Brown, corresponding secretary, will take the minutes for tonight's meeting.

Diane Silvestro, treasurer, reported \$8268.21 in the treasury and \$1706 in unrestricted funds. A savings account has been opened at Lockport Savings Bank. She thanked Kathryn Callahan for her work with Election Services which brought in \$261.80.

### Reports:

Maryalice Seagrave had four members at the Channel 17 "festival." If we get enough

members for the March "festival" we may be able to get a plug in for the Sports Equity Program.

Cindy Monacelli reported a Chamberlin Loan Fund balance of \$16,665.51, and Funds for Education balance of \$8097.12. There is no legal prohibition for the change in the name Funds for Education.

Jane Fischman needs interviewers for December 26. Thirty applications have been picked up. Jane asked if men are eligible for loans. The Chamberlin Loan stipulates "women," Funds for Education does not. The board agreed that since membership is open to men, this should be too.

Joan Ward sent out news releases for the tea, inviting prospective members. She needs information for January and February programs and a daytime contact number to include with Sports Equity Program releases. Diane Silvestro offered her number. Joan announced for Barb Olandt that the grant of \$4450 for the Sports Equity Program came through.

Suzanne Grossman reported all committees are functioning well.

Sharon Rich reported no new members, but several requests for information. There will be a membership meeting on January 5, at 7:30, in her office. The January program on Sexual Harassment will be preceded by the new member orientation.

Judy Weidemann reported that the equity presentation is almost ready to take on the road.

Karen Stephenson announced that the Buffalo Philharmonic and Chorus received a grant for an Art Park program during the World University Games. The program will include a group from Germany. Perhaps a group AAUW outing could be planned.

Carol Jamieson thanked Barb Carier for her By-laws work. Carolyn passed out copies.

Ann Bish and Carolyn Day attended a meeting of the presidents of local women's

organizations sponsored by the Erie County Commission on the Status of Women. Ann Bish read a letter she received in response to the AAUW legislative committee letter concerning funding for this commission. Funding was budgeted for the chair but not for any support staff. Over 30 members volunteered to help with the Holiday Tea. She also asked for items of interest for newsletter fillers.

**Old Business:**

Carolyn Day reported the Hurricane Andrew relief fund at \$157. Ann Bish moved to send at least \$200 to the United Methodist Relief Fund. If under \$200 is raised, the treasury will make up the difference. The motion was seconded and passed.

The February board meeting is the 3rd as originally scheduled. Only one ad for the newsletter was received. This will be held for a future issue.

**New Business:**

Jill Brown asked if it was necessary to send a thank you to Benjamin Franklin Middle School for the use of the facility for meetings. It was decided not to do so at this time.

Maryalice Seagrave asked the board to consider the accountant's recommendation that the treasurer be given a stipend. Barb Carier moved that we decline this suggestion. This motion was seconded and passed. The board will look at job descriptions and try to divide the treasurer's current responsibilities as outlined in the By-laws.

A motion for adjournment was made at 9:00 pm.

To the Editor:

We hope that we are experiencing more of the "Year (years!) of the Woman" as time goes on. Women's successes in working together for common goals and asserting our needs and rights in the patriarchal system we live in, have varied widely. We recently saw a discouraging collapse of all cooperation during the New York Senate race. Two supposedly bright and insightful women fought each other instead of trying to work together for the benefit of the women in their state. As a result, another hopelessly male, anti-woman, anti-choice, please-ball retained his Senate seat!

It pains me a great deal when women I know in a group such as our branch of AAUW, go through periods of internal dissension, struggles for power and lack of appreciation for each other. Instead of realizing that all our efforts are built on the efforts of the women who worked before us, each tries to claim that only she knows the right way and that anyone who does things a little differently must be a "troublemaker" and considered an enemy. We treat each other less kindly than we do men, and forget that each of us in our individual life has experienced put-downs, lack of respect and support, general emotional malnourishment -- which should remind us to treat each other with the love and tolerance everyone needs. Think about this for the new year.

## EDUCATIONAL FOUNDATION

The AAUW Educational Foundation is the oldest and largest non-university program supporting higher education for women in the world. Ida Street, a Vassar College graduate, was the first fellowship recipient in 1888. She used her \$350 AAUW fellowship for graduate work in English Literature. In the 1991-92 Funds for Education year, approximately \$2,268,800 was raised and \$2,180,421 was awarded to 245 women out of 2493 applicants.

Each year AAUW State and local branches across the country launch fund raising projects that raise money for fellowships and grants. It is the hard work and financial support of each and every member that allows AAUW to continue year after year to sustain the educational goals of so many women.

To continue this work the New York State AAUW Educational Foundation has set the following goals:

1. Raise \$85,000 in 1992-93.
2. Have 21% of members join the Twenty-First Century Club in the next three years.
3. Promote Equity Futures (all money contributed is designated for the Eleanor Roosevelt Fund).
4. Sell items from the NYS Custom Collection.

The Twenty-First Century Club was formed in 1992 to continue commitment to the future of AAUW. The membership fee is \$210 and you can pay either the full amount at one time or make a pledge to pay three installments of \$70 each over three years. The membership fee can be designated for a specific NYS Endowment, or an International Endowment. Please see the attached form for more information.

Equity Futures provide a wonderful way to honor or memorialize a special person. The minimum donation is \$25 and all monies raised

go to the Eleanor Roosevelt Fund. A form is attached for your convenience.

This year NYS has a Custom Collection for sale; included is a decorated ceramic tile - this is absolutely lovely - elegant cream and NYS Blue with a quotation by Matilda Joslyn Gage, a friend of Susan B. Anthony. (Price: \$10) The collection also includes a looking glass, a letter opener and a luggage tag. These are priced at \$2 each or three for \$5. ## E.F. HEADLINERS

Members of AAUW should be proud of the fact that our contributions to the Educational Foundation promote women leaders of outstanding ability and promise. Recently the names of three women have appeared in National News Reports.

Donna Shalala, former Chancellor of the University of Wisconsin, has been chosen to be Secretary of Health and Human Services in the Clinton Administration. In 1976, she was honored by AAUW as a recipient of the Recognition Award for Young Scholars.

Hannah Gray, President of the University of Chicago since 1978, received an Educational Foundation American Fellowship in 1953. In 1993 she will return to teaching at that institution.

Nannerl Keohane, President of Wellesley College, will become the first woman president of Duke University in July 1993. She, too, had

received an AAUW Educational Foundation American Fellowship (1966).

It is helpful to see how our fund raising efforts for the Educational Foundation are contributing to the advancement of women.

#### UPDATE

#### Erie County Commission on the Status of Women

On November 17, AAUW sent a letter to County Executive Dennis Gorski and every Erie County legislator urging them to satisfactorily fund the Commission on the Status of Women. Our letter was clocked into the Erie County Legislative Agenda for consideration at their bimonthly session.

On November 19, Pat Swift's informative article appeared in The Buffalo News in which she reiterated the conditions - past and present - of the commission's struggle for life. Swift referred to Susan Gaska, chairwoman of the commission, who stated that the commission would fade into oblivion if, as Gorski proposed, the commission becomes a part of the Office of Public Advocate. (The commission would share an office with the Equal Employment Opportunity Division, Veteran's Services, and the Community Coordinating Council on Children and families.)

On December 1, the budget came to a vote. "The legislators were persuaded by ...women's groups to kill Gorski's plan to cut three jobs by creating an Office of the Public Advocate. The office would have been an umbrella agency for the Commission on the Status of Women..." (The Buffalo News, 12/2/92). Hopefully, County Executive Gorski will not veto the legislature's good intent.

Is there any doubt that writing to legislators can make a difference? When women collaborate and pull together the outcome of their efforts can be very effective. Congratulations, Lynn Marinelli, Executive Director of the Erie County Commission on the Status of Women! (And a new member of AAUW).

#### Writing Your Legislator

In this newsletter you will find a list of legislators, their addresses and phone numbers. Please keep this list in your roster as a useful reference for future contacts. In fact, we encourage you to send support letters to your legislator on one or all of the following new laws in New York State:

1. Standby Guardian: Chapter 290, establishes procedures and standards for the court appointment of a standby guardian when a parent is at risk of dying or becoming incapacitated.
2. Rape Evidence Kits: Chapter 383, requires hospitals to maintain sexual offense evidence for one month. The former 96 hour period was insufficient for women who decided to report or prosecute the crime.
3. Cervical Cytology Screening (Pap Smear): Chapter 771, requires insurance policies which provide hospital surgical or medical care to also provide coverage of annual cervical cytology screening for women ages 18 and over.

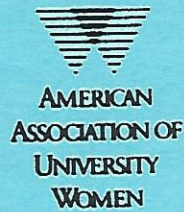
