Ewing speaks on the realities of family violence

A pernicious myth, according to Dr. Charles Ewing, who spoke at the October 23 Buffalo Branch meeting, is that domestic violence only happens to

others. The reality is that family violence is not confined to a particular neighborhood, economic level or region; it is, in fact, in all social and economic strata. In the case of the battered woman, there are two underlying causes: attitudes toward women and the perpetuation of physical, psychological or sexual abuse learned in the home that becomes the acceptable norm. The need for control or power is the key issue.

We may wonder why women continue to stay in such devastating situations. Dr. Ewing discussed the reasons for their entrapment. Repeated demeaning messages (you are to blame, you are at fault, you can't make it in the "outside world") are internalized and lead to crushed selfesteem, hopelessness, helplessness, depression, even possible suicidal ideation. Psychological abuse may be so severe that it affects the woman's physical well-being. Dr. Ewing emphasized that external factors also contribute to the victim's entrapment. In short, the batterer is unwilling to lose control; there is a lack of social services to handle a victim's plight (shelters, financial support, children), and our legal system does not understand the human dynamics of family violence. Furthermore, the system fails to recognize that domestic violence is a crime. And the sad truth is, according to Dr.

Ewing, even with long term therapy the likelihood of rehabilitating the batterer cannot be assured.

The reality is that family violence is not confined to a particular neighborhood, economic level or region; it is, in fact, in all social and economic strata.

How can we as individuals respond to the increasing epidemic of domestic violence? Some suggestions Dr. Ewing and members and guests offered were as follows:

- Reach out to families, friends, neighbors in trouble;
- Encourage our schools to consider programs on violence, such as "Say No to Drugs and Sex;"
- Write letters to television stations expressing displeasure with their selection of programs depicting excessive violence;
- Write letters to commercial sponsors indicating that we are not buying their products because of their promotion of violence on TV;
- ~ Support agencies such as Haven House which is doing a remarkable job in our community in helping women and children;
- Support and vote for qualified women for public office. (Dr. Ewing noted that Buffalo is fortunate in having two exceptionally effective Family Court women judges, Sharon Townsend and Marjorie Creola Mix).

In sum, more must be done to help those who are victimized in our community.


In the spotlight this month is Ruthe Sicherman who has found her 42 years in the Buffalo Branch both rewarding and fulfilling.

The religious right is wrong

AAUW's concern for the antithetical policies and political thrusts of the religious right was expressed at the Public Policy Focus Workshop at the District meeting in October. Moreover, in the November issue of Action Alert, AAUW reports that Concerned Women for America (CWA), a religious right organization, is organizing to defeat HR 1793 (House of Representatives: Gender Equity in Education Act) and prevent the kind of reforms that are so vital to ensure women and girls a bias-free environment for learning. This organization is anti-choice, anti-gay, and anti-women's rights. It has an extremely strong grassroots network. According to the report in Action Alert, many Congressional offices have been receiving calls and letters opposing HR 1793. CWA claims that the bill "encourages promiscuity and sexual experimentation." In short, CWA's broader agenda is to encourage censorship, to provide vouchers for private and religious schools, and to remove sex education and drug prevention programs.

ACTION is imperative at this time. It is URGENT that we contact our representatives in support of this bill. Also, watch for and respond to letters to the editor concerning gender equity.

AAUW establishes criteria for health care reform

AAUW's role in the health care debate is to advocate for the specific needs of women of all ages, races, and socioeconomic class. In

evaluating the many health care proposals being introduced into Congress, AAUW will consider the following five criteria:

- Universal coverage/access to quality health care;
- A standard package of comprehensive benefits, including comprehensive reproductive health care, emphasis on primary and preventive care, and comprehensive long-term care (at least to be phased in);
 - A full range of providers and settings;
- Accountability: diversity of representation on health advisory boards in states and communities;
- Action Alert, November

Public Policy Program wins approval

Association Director of Public Policy Karen Gallagher kicked off the 1993 Convention's consideration of the proposed 1993-95 Public Policy Program by highlighting recent AAUW accomplishments in the public policy arena. Health rights for women was added to the Association's public policy priorities in 1991. Since then, AAUW has joined other organizations in advocating full coverage of women's needs in the health care reform proposal being developed by the Clinton administration.

Gallagher thanked members for contributing almost \$265,000 to AAUW's second Campaign for Choice--contributions that supported action to preserve reproductive rights in states across the nation.

Finally, she pointed with pride to the Gender Equity in Education Act (GEEA). This federal legislation was written largely by AAUW and introduced in the U.S. House of Representatives in April. GEEA would provide federal funds for gender equity components in key federal elementary and secondary education programs. Gallagher asked members to write to their representatives to urge support for GEEA as soon as they return home from Convention.

Following the report on AAUW's policy activities, delegates took action on the Public Policy Program. The only amendment offered was to move support of the Equal Rights Amendment from the Public Policy Principles for Action section to the Biennial Action Priorities section. The amendment was defeated, and the Public Policy Program was approved as proposed.
