She is one of the official United States Non-Government Organization (NGO) delegates to the United Nations Fourth World Conference on Women's Issues being held in Beijing, China, from August 26 through September 8, 1995. Accompanying her will be Dr. Elizabeth (Betty) J. Cappella. Bard is Chair of the delegation from Buffalo and Erie County, and Cappella is vice-chair. They are representing the National Women's Conference Committee with Sarah Harder, national past president of AAUW, and are leading the United States delegation. Bard and Cappela were selected to present their paper, Women, Education, and Family Literacy: Strategies for Empowerment, to the conference.

Their workshop offers specific strategies to be incorporated into family literacy programs which focus on education toward equality; women's human rights; community development as it impacts on the political, social, and cultural aspects for job skill training; programs for at-risk children; family ecology; illiteracy; and the prevention of violence against women.

If you have not yet seen the Paley exhibit at the Albright-Knox Art Gallery, you still have a month to go and view many extraordinary works



of art. The Shaw and Stratford Festivals will continue until October. While both perform theatre of extremely high quality, if I had to pick a "must-see" at each, it would be Cavalcade at the Shaw and Long Day's Journey into Night at Stratford. Artpark will be presenting the musical

Forever Plaid at Artpark-at-the-Church throughout the month of September.

The big September event is CURTAIN UP on the weekend of the 22nd to the 24th. For Shakespeare fans who don't wish to travel as far as Stratford, two local companies are collaborating on a production of *King Lear*. ASSOCIATION CONVENTION REPORTS: HIGHLIGHTS, MEMORIES, AND NEWS

In June 1995, it was my privilege to represent Buffalo Branch at the Association Convention in Orlando, Florida. Being on the grounds of Disney World in the Contemporary Hotel and Convention Center was very exciting, but no special setting can equal the thrill of participating in the discussions and discoveries of an Association which re-defines and further refines itself every two years.

We learned that in 1994-5 Association membership grew by 5 percent nationwide. Perhaps the 420 branches across the country – including Buffalo – who met goals to become 5-Star branches are part of the reason for this increase. Those branches were honored on the first night of the Convention.

The opening session was a wonderful mixture of fun and earnest contemplation of our mission. Giant TV monitors assisted the views of Mickey and Minnie Mouse dancing to welcome us, a choral group and color guard of Girl Scouts, and welcoming remarks from not only our own President Jackie DeFazio and her Canadian counterpart, Phyllis Scott, but also from First Lady Hillary Clinton, by video from the White House. Mrs. Clinton praised AAUW's history, goals, and successes, and urged us to continue the struggle to help girls, and all children, in light of the current Congressional realities.

After Orange County Chairman Linda Chapin stressed that the traditional "women's issues" have become the most pressing social issues of the day, it was our Jackie DeFazio who outlined a new effort for AAUW to work to reverse the results of the 1994 election. The

Association Board has authorized all branches to begin immediately to refocus their efforts on a new Voter Education Campaign. The last Congress voted with AAUW's issues about 85% of the time; this Congress has a "score" of 0%! Voter education is mandatory to let people know that every issue promoting education and equity for women and girls is in danger! AAUW's top legislative priorities have become ideological battlegrounds. Recent gains for all women and girls in educational equity, civil rights, equal employment opportunities, and reproductive choice are threatened by the legislative agenda of the new congressional leadership. Even the Gender Equity Act, which was passed less than a year ago, isn't safe. The legislators constituting the new congressional majority aren't listening to anything we are saying because they have a different agenda.

The attacks are too broad and from too many fronts to defend. We must change the key players in 1996 or face further erosions of the hard-fought advances we've won. We need to harness our outrage into action. If women had voted in the same numbers in 1994 as they did in previous elections, the composition of the present Congress would be quite different.

With this challenge echoing in our minds, Buffalo Branch should consider the establishment of a Voter Education Campaign team/task force. Someone must identify potential partners in this campaign and take the lead in disseminating information and action ideas. It sounds like an AAUW project if I ever heard one!



JUNE BOARD MEETING

The Buffalo Branch Board of Directors met on June 3, 1995, at 7 p.m. at the Reinstein Branch, Cheektowaga Public Library. President Judy Weidemann called the meeting to order. The following reports were given:

President's Report – Weidemann reported on the Boot Camp for board members, a New York State AAUW Leadership Training Session to be held on July 15, 1995, at the College of St. Rose in Albany, New York. Weidemann also mentioned that Gail Eagan was honored at a Women's Action Committee luncheon.

Used Book Sale Report –Jackie Trace and Rosemary Darbee reported that the sale will be held at the Tri-Main Center, 2495 Main Street, Buffalo, New York. A bulk mailing has been sent to each Buffalo Branch AAUW member explaining what has been done so far and problems that exist. Bookmarks, which were donated, were included with the mailing. Sorting for the sale has started. A phone list of new members will be compiled, and they will be called; the committee is looking for tables at a good price; and the sign for the marquee will be set up in front of the building. The committee will meet every Thursday at 7 p.m. at the site until the sale is over.

Second Vice-President for Membership Recruitment Report – Marlene Dick has sent out 140 letters this year and has recruited 70 new members. Coffees will be held in January and August for new members. Articles will be placed in alumni publications from the University at Buffalo, Buffalo State College, and Daeman College. Fifty brochures have been sent to Welcome Wagons.

Third Vice-President for Membership Retention Report – A meeting is planned for June 11, 1995, to work on a membership list. The committee consists of Bunny Blackstone, Carolyn Day, Judy Weidemann, Lois Meyer, and Joan Allison.

Treasurer's Report – Lois Meyer reminded all officers to submit their expense vouchers. Meyer submitted her treasurer's report showing this year's total income as \$7,266.58, and the checkbook balance at \$4,252.45 after expenses. The savings account has been transferred to the Rochester Savings Bank. The treasurer's report was accepted and filed for audit. Meyer also circulated a letter with a notice regarding dues renewal, which she suggests be sent to members.

Loan Funds Treasurer's Report – Cindy Monacelli presented her report showing \$31,884.80 in the Chamberlin Loan Fund and \$6,909.61 in Funds for Education. The report was accepted and filed for audit.

Educational Foundation Report – Stacey Johnson presented her report showing a book sale checking account balance of \$4,462.86. The report was accepted.

Chamberlin Loan Report – Maryalice Seagrave passed out the new applications for the Chamberlin Loan Fund. They have been slightly revised. The major change was the section applying to budget. Ann Hicks has had the applications printed. There were a few interviews conducted before the meeting, and the rest of the candidates will be interviewed on June 29, 1995. Seagrave brought to the attention of the incoming board the fact that the guidelines by the Ad-hoc Committee need to be reviewed.

Finance/Budget Report – Diane Silvestro reviewed the profit and loss at the end of the year.

Legal Advocacy Fund Report – Carolyn Day reported that the Association has taken a few more LAF cases. Day also reminded the board that the branch must send a list of our upcoming events to the Women's Action Committee for their calendar.

Study Groups Report – Judy Bratty stated that as a new member, she was very happy to be asked to coordinate the study group activities and is happy to be continuing next year.

College/University Relations Report – Karen Noonan stated that her work in recruiting college/university members has been difficult and not as successful as she would like it to be.

May Luncheon Report – Outgoing
President Judy Weidemann congratulated Alice
Mason, May Luncheon Chair, on a job well done.
Mason has set up guidelines to help next year's
chair. She will also publish thanks in the
newsletter to all workers. Lois Meyer has a
summary of expenses for future use.

Weidemann turned the meeting over to new President Bunny Blackstone.

Blackstone thanked Weidemann and the old board for their work and welcomed the new and continuing board members. Blackstone asked for more effective communications between members and the board. The following suggestions were made: a phone tree to connect the members, a new member's study group, programs that will appear to members on a broader range. Blackstone mentioned that the new board is not complete, and that Newsletter Editor Betty Loucks will be needing some help with the newsletter.
