# December 1996 AAUW Board Meeting

The December Board meeting of AAUW Buffalo Branch was called to order by President-elect Diane Silvestro on December 4, 1996 at the Snyder-Eggertsville Library at 7:00 PM.

The minutes are accepted as presented.

The following reports were made:

Diane Silvestro circulated correspondence. Silvestro announced that the January Board meeting will be held at her home. The meeting will focus on the future of the Buffalo Branch. Barbara Carier will present a workshop on strategic planning.

Treasurer's Report: Bunny Blackstone reports that we have \$8553 in our checking account and approximately \$3000 in savings. The amount in the general fund is unknown. Blackstone will organize a finance committee meeting to formulate a balance sheet and income statement for '95-'96 and bring it up to date for '96-'97 when all our material comes back from the accountant. Blackstone and

Maryalice Seagrave have been working on a budget. Voter service brought in \$201.60.

Study Groups: It is the policy of AAUW Buffalo Branch to allow a non-member to attend study groups 3 times without joining. It was suggested to have the leader of each group or the non-member's sponsor encourage the non-member to fill out an information sheet and be encouraged to join AAUW.

LAF: We have reached our goal for 5 - star status. Baskets prepared by Study Groups will continue to be raffled at monthly programs. Extra items will be used to make up baskets which will be raffled at the Book Sale. Any funds raised over our obligation this year, will be held by the Treasurer for next year's fund raising.

CONVENTIONS: New York State Convention will be held at Saratoga Springs May 2-4, 1997 and the Association Convention at Disneyland Anaheim, California June 21-24, 1997. Barbara Carier agreed to act as coordinator for both conventions.

A motion was made to purchase an 1/8 page ad in the New York State Convention Booklet for \$25.00 out of special projects fund to be used for advertising our Branch and our sale items. Ann Hicks agreed to submit the ad by the deadline.

Nominating Committee: Margit Spector asked for any candidates names for 1997-1998 be turned into the nominating committee.

Theater Fund Raiser: AAUW will offer tickets for Agatha Cristie's "Witness for the Prosecution" in March 1998.

### BOARD POLICY ON NON-MEMBERS ATTENDING STUDY GROUPS

At the December meeting of the Board of Directors, it was decided to reiterate the policy on the attendance of our study groups by non-members. Our study groups have been organized by and for the benefit of our members. They are a prime reason for joining the Buffalo Branch of AAUW. Non-members are welcome to attend under certain conditions in an effort to attract eligible persons to join AAUW. Membership applications will

be made available to members bringing guests to study groups and these guests will be encouraged to join AAUW. If there is a pressing financial need which prevents non-members from joining our branch, the sponsoring member may contact a board member in confidence to present the non-member's case to the Board of Directors.

\*Non-members may only attend three study group meetings per year.

## Chinese New Year Celebration

Su Fang Cui, a graduate student in economics, and Yu Feng Qian, a Chinese language instructor from Beijing University, entertained members and guests on Sunday, December 8th, as we celebrated the Year of the Ox and feasted on Dim Sum, appetizer sized dumplings, pot stickers and other goodies.

Dim Sum, Cantonese for "heart's deligh", is a traditional Chinese brunch and can be enjoyed at several local restaurants including Rita's Crystal Palace (Amherst), New Spring Chinese Restaurant (Fort Erie) or Sui Sun Bakery (Niagara Falls, Ontario). Most items consist of two or three pieces and are meant to be enjoyed by a whole table, so invite your friends or family to join you and enjoy such delicacies as Ha Gow (steamed shrimp dumplings), Cha Siu Bau or Sui Mai (steamed buns or dumplings filled with meat), or shrimp toast, pot stickers (fried dumplings filled with vegetables), Jien Dui (sesame seed balls filled with red bean past), turnip cake or stuffed eggplant.

Local opportunities to take part in celebrating the Year of the Ox, which occurs February 7th, 1997, include traveling to Toronto, Ontario. Festivities will include the traditional dragon dance, firecrackers (which are used to chase away the evil spirits), visiting friends, good food and gifts of money in red tissue paper. We learned that the Beijing municipal government has now banned firecrackers in the city because of numerous accidents and the noise. This reminded many of us of our own

problems on the 4th of July. In addition, the students shared with us some of the stories associated with this Spring Festival and we all had a chance to learn more about ourselves as Yu Feng explained the Chinese Zodiac.


