Seasoned political professionals will train participants in the art and science of campaigning. The Town of Amherst is a case in point. Susan Grelick, elected Town Supervisor in November has vacated her position as Town Clerk (salary \$ 55,000). According to the Buffalo News she was a new comer in 1991 when she answered an ad placed by the Democratic Committee looking for candidates to run for office. The Town Clerk is the chief records management officer and recording secretary for the Town Board and Zoning Board. Not interested, what about the Town Council (salary



\$21,400)? Don't live in Amherst? What about Boston, Buffalo, Cheektowaga, Clarence, Elma, Hamburg, Kenmore, Tonawanda, or West Seneca? I am sure your local Democratic and Republican Party Chairpersons are looking for candidates, so give them a call.

So you aren't interested in being a candidate, what about managing a campaign? Keeping active in the political process requires more than just remembering to vote in November or writing a letter to your local representative once in awhile. Our branch was actively involved in the AAUW Voter Campaign for '96, let's keep involved in '97 as well!!!!

AAUW Research Publications Go 'Round the World

The scope and impact of the education and equity research done by the AAUW Educational Foundation has continued to be far reaching. The Spring/Summer 1997 issue of "MemberLink," published by the Wellesley Centers for Women, reports that the *AAUW Report: How Schools Shortchange Girls* was printed in French, Spanish, and Mandarin Chinese as well as English prior to the 4th World Conference on Women. Copies were distributed to thousands of attendees at the Beijing Conference in 1995.

CURRENT PUBLIC POLICY ISSUES

In April the Public Policy Committee provided a pull-out roster of the names, office addresses, and phone numbers of elected public officials. For local matters, Erie County Legislators are listed in the Government section of the telephone directory.

Two Congressional hearings focusing on Pell grants and Title V of the Higher Education Act were held in March. Also, President Clinton's administration proposed a package to increase access and expand eligibility for Pell grants. He further proposed tax credits and tax deductions for students and families of students in post-secondary education. Please contact your Members of Congress and urge them to continue this support of improved accessibility and affordability of higher education.

That there is gender inequity in salaries and appointments, and women are generally less-valued by the university community than men, was substantiated by the report. Hopefully, the recommendations in the report will be prioritized to move forward on the issues without getting involved in a lot of hairsplitting over who did what to produce this in the past. The senators were told that the impetus for changing the environment for women at UB has to come from the faculty. MORE OF THE PAST

Some strange and interesting things happened during the early years. The second sale was almost wiped out by a two day blizzard. Fortunately, the sun shone on Saturday, and the branch showed a profit of \$623.

During the third sale someone contributed 15 volumes of the Foundryman's Journal, which were unlikely to sell. On the last day of the sale a man discovered them and purchased the whole set. He had just bought a small foundry.

When Mrs. Wilson B. Gragg chaired a sale on upper Main street, she was surprised to find a number of slot machines in a back room. A day later, when the police came to investigate, the machines had disappeared.

One year we almost had a baby for sale. Two women came in the store, one carrying a sleeping baby in a basket, which she put under one of the tables in the back of the room while she selected books. After a while the women left, did some shopping, and returned to collect their books and the baby. The workers, who had discovered the baby after the women left, breathed a sigh of relief.

In the early '70's the William Hengerer Company set up depots in all their stores where books could be dropped off. The area YMCA's also had places set aside for collection. The Butler Library at Buffalo State College aided in the collection process, as did the Emma Bookstore, formerly run by Anne Montes, AAUW member and sale chairman.

UB's President's Task Force on Women

The President's Task Force on Women at UB had regular meetings from December 1994 through April 1996. They confirmed that, a salary disparity does exist between some male and female faculty members, females are most represented at the lower levels of jobs, the mandate for affirmative-action searches needs tougher administrative enforcement, and female representation as undergraduates are below average. There is still a thick glass ceiling at UB (I was tempted to say, "What a surprise!", but thought it beneath me).

Among the task force's recommendations outlined by co-chair Bernice Noble, professor of microbiology, at the Faculty Senate Executive Committee at its February 5th meeting were:

- Establish an Office for Women to maintain data, serve as coordinator of activities and publicity, increase university wide awareness of women's perspectives and workplace needs, identify women leaders and conduct climate surveys. Until such an office is established, the task force suggested it be extended to include these functions.
- Increase the representation of women, particularly at the higher levels of academic and managerial units.
- Develop a procedure for dealing with sexual harassment.
- Establish child-care facilities on the North Campus.
- Promote scholarship around gender issues and women's issues.

YES WE CAN!

The AAUW Report: How Schools Shortchange Girls, funded by the Eleanor Roosevelt Fund of the Education Foundation and published in 1992, impelled interested members of the Buffalo Branch to start meeting in August 1992 with the goal of creating a program increasing awareness in the community of equity in education for girls and women. They produced an "Equity Notebook" containing publications from the AAUW national office, collected press clippings, made overhead transparencies, obtained a copy of the AAUW tape *Shortchanging Girls, Shortchanging America*, and developed a narrative. Several presentations were given throughout 1993 by this dedicated team.

In November 1993, they met to integrate the report *Hostile Hallways: The AAUW Survey on Sexual Harassment in America's Schools* into their educational equity initiative, while informing members about the research in the September and October 1993 newsletters. Continuing to review and refine branch plans and options, the committee developed and published guidelines in the newsletter that parents and teachers could use to combat gender inequity and sexual harassment in our schools. In 1994, a letter was sent to every superintendent and staff development center in Erie County introducing AAUW and the current research and resources our branch was prepared to offer the schools or districts

to help them address these issues. This letter released a flood of requests for presentations and work shops that has continued into the present. The initiative of a nucleus of interested branch members has developed a life of its own. The village of members who gave birth and continue to nurture this project has had some steady residents and some transients who stayed as their lives permitted, but each one helped it to grow.

Members continue to give presentations, the most recent are: March 5th and 12th, Barb Carier addressed the school districts of Cheektowaga, Maryvale, Sloan, and Cleveland Hill at the Teacher's Center of Cheektowaga (TCC) on Gender Bias and Sexual Harassment.

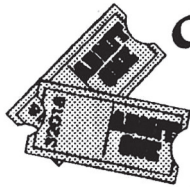
April 12, Barb Carier gave a presentation in Olean for the 17 schools districts of Allegheny and Cattaraugus Counties on Sexual Harassment in Schools.

April 27, Judy Weidemann addressed Nardin Elementary and High School Parent Association on Equity in Education.

the federal budget by means of a Constitutional Amendment would not ensure adequate flexibility to meet the needs of women and their families; passage would disproportionately impact on our priorities of education, health care and welfare. The Senate defeated the amendment, but it may come to a vote in the House. Please contact your Representative and urge opposition to the Balanced Budget amendment

On March 13, the U. S. Department of Education released guidance to clarify behaviors which constitute sexual harassment in educational institutions. Copies are available from the Office for Civil Rights, US Department of Education, 330 C Street, S.W. Room 5412, Washington, D.C. 20202. Please make sure your local school has a copy of the guidance and has a sexual harassment policy and complaint procedure in place.

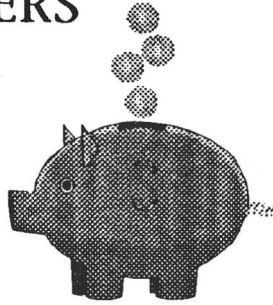

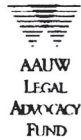
