## **AAUW NYS Convention in Lake Placid**

One by law change and two resolutions were presented to the voting members of AAUW who attended the NYS Convention at Lake Placid on May 3, 4, and 5.

The by laws change was a proposal to elect an LAF VP on the NYS Board of Directors. This would bring the NYS Board in line with the Association Board with VPs for both the EF and the LAF. Currently, the LAF board member is appointed by the president. This was passed unanimously.

Next a resolution from the NYS board to revise the criteria for membership was proposed. The resolution proposed that the Association revise its membership regulations to give full membership to all women and men who support equity for all women and girls, lifelong education, and positive societal change. This resolution, if passed, was to be presented at the Association convention in Providence next June. This resolution was debated vigorously and was then defeated. In my opinion this was a good thing. If we are going to give up all requirements for membership, how can we retain our name and our dedication to higher education for women?

The next resolution was presented by Hortensia Stoyan from Queens branch that proposed a membership category for community college graduates. This was also defeated. This issue will be hotly debated at the next convention. The Association already has a Committee on Alternative Ways to Affiliate that will be reporting at the convention. We are certainly looking at our membership qualifications and it will be interesting to see what the results will be for the organization. Sue Oliver
