

Back to the Future

Remember when we had to fight for the vote? When a woman couldn't own property in her own right, and when colleges were closed to her? Well, of course you don't. Those fights were fought by generations no longer alive. But perhaps you do recall when *Rowe versus Wade* was debated in the streets, as well as, in the courts, or when girls' sports teams were items on our wish lists rather than realities on our playing fields or in our gyms, courts, and pools? Maybe you have a relative or friend who wasn't admitted to her chosen field or denied a promotion of influence in a corporation or university in spite of being highly qualified.

Hey, everyone knows those days are over. I mean, women have come a long way, can now do or be anything they want, just like men. No problem. No obstacles left, right?

If you believe that, then it will surprise you to know that as we speak, Congress and state legislatures are passing bills and riders to bills obstructing your right to personal choice of certain medical procedures and your fundamental right of free speech in discussing available options with your personal doctor. Equity? Fairness? Both businesses and universities instruct their people to report infractions of EEOC standards and institutional policies against sexual harassment, then retaliate against the women who actually do so. Mutual respect among men and women? What about gender discrimination in general? Unfortunately it is still firmly entrenched in too many corporate and scholastic cultures. The problem is actually increasing as businesses and universities discover more sophisticated and covert methods to achieve the same ends. Of course you know that LAF supports those women who have to fight the battle in court, but it will probably come as a shock to you to realize that

some of that discrimination and obstruction comes directly from our AAUW sisters.

Sad to say, it has been reported that some state and branch boards resist or even overtly obstruct activities on behalf of the AAUW Legal Advocacy Fund including even the dissemination of information on gender discrimination and sexual harassment. As members of AAUW, where is their adherence to our Mission Statements declaring support for equity for all women and girls, lifelong education, and positive societal change?" And what can the rest of us do about it?

There isn't a branch, a board, a committee that would not benefit from an AAUW Mission audit - setting aside a meeting, an hour, or even a few minutes to raise the group's collective consciousness, reminding members that the reason AAUW has been so successful since 1881 in encouraging girls and women toward their educational and personal goals is because we adhere to those ideals that founded our existence, to the original statements espousing diversity, equity, educational excellence, and societal change. We demonstrate these beliefs with our lives by placing our money, our efforts, and our reputations where our hearts are. Laboring toward these goals inspires others to achieve them.

Going back to the future of these fundamental ideals allows those of us who believe whole-heartedly in AAUW and the Legal Advocacy Fund to go forward with renewed pride and determination to root out those pockets of discrimination wherever they exist. As the saying goes, "If not us, then who? And if not now, then when?"
