AAUW Launches New Mentoring Program

AAUW's Buffalo Branch will hold the first session of its new mentoring program on Saturday February 4, at 11 a.m. at Kensington-Bailey NHS, 995 Kensington Ave., Buffalo. The session, titled "Kickoff: Your Road to Success," is designed to start participants thinking about long-term goals.

The mentor program is aimed at middleschool girls, ages 11 to 14. It is designed to reinforce the importance of education, staying in school, the benefits of a college education, and to expose the girls to new experiences. Four sessions will be held during 2006. A "Just for Moms" program will also be held at each session for the girls' parents/guardians.

While we have enough mentors for the girls, the program could still use members to talk to parents and to help with set-up and cleanup. LAF Corner

As we ponder the New Year, one is filled with anticipation and hope. In reflecting upon the Legal Advocacy Fund, I hope that this year will see many successes in our support of individuals challenging sex discrimination, harassment, or enforcement of Title IX. While we have made a great deal of progress over the years, we still have a long way to go.

Women are still finding it extremely difficult to find promotion to tenure in the field of science. The case of Professor Russell at Princeton University is an example of that. She believes that if the University had investigated her charges of discrimination after they found a serious problem in the way her case was treated by two administrators, a lawsuit could have been avoided.

Women have difficulty achieving equality in sports programs at all levels. The case of the four women wrestlers at the University of California at Davis exemplifies the difficulty women have in attempting to compete in a nontraditional sport. They were no longer allowed to participate in the school's varsity wrestling program. They sued for alleged violation of the Title IX Education Amendments of 1972. When their coach, Michael Burch supported them,

his contract as wrestling coach was not renewed. Thus, he sued alleging retaliation for his support of the female wrestlers.

This case is most important because UC Davis ELIMINATED men's opportunities in order to comply with Title IX. In 2003, the US Department of Education's Office for Civil Rights clarified that eliminating men's opportunities is not the same as adding women's opportunities. Schools should not be able to hurt men claiming they are helping women. This case has the potential to establish a precedent to define what it means for a school to have a history and continuing practice of adding women's teams in order to comply with Title IX's mandate to provide equal opportunities. This case has the potential to make clear that schools must continue to ADD women's teams until they reach equity.

Thus, we find that 2006 continues to bring us more challenges. These people depend on the Legal Advocacy Fund to aid in their pursuit of justice. The Legal Advocacy Fund depends upon your contributions. Perhaps you could consider putting aside a small amount monthly to reach a higher goal. Please be generous. We are the forefront of creating systemic change in our society. I am confident, that with your help, we will be successful.

Consider for yourself what relevance the contents of this production have on our current day life in Buffalo, N.Y.

The Souls of Black Folk by W. E. B.

Du Bois is probably the most influential or, at least, most discussed book published by a black American intellectual in the twentieth century. *The Crisis of the Negro Intellectual* by the late Harold Cruse and a few other volumes rate closely behind this masterwork. It is not strictly a history of African-Americans; indeed, it is almost a synthesis of forms: biography, fiction, historical and economic analysis, and autobiography. One might think of some other Du Bois books that are more strictly historical, like *The Suppression of African Slave-Trade in the United States of America, 1638-1870* and *Black* *Reconstruction*, but none seem to have captured the major issues facing the black masses and the black elite as this work did, and none of his other books are widely read. This is Du Bois's analysis of the New South and race.
