Barbara Nevergold, Ph.D., co-founder of the Uncrowned Queens Institute for Research and Education on Women at the University at Buffalo, is one of five people honored this year by the State of New York with a 2007 Dr. Martin Luther King Humanitarian Award. She was also inducted into the WNY Women's Hall of Fame on March 12 of this year.

Marguerite Collesano received the D'Youville College Distinguished Service Award on March 7, 2007. Marguerite received the award for continued service to the College over the years including presidency of the Alumni Association and membership on the Board of Trustees.



MEET THE BOARD:

Teresa Gessner is co-chair of the Public Policy Committee.

Born in Poland, she attended schools in Persia, Lebanon and England and completed university studies in England, graduating with B.Sc. and Ph.D. degrees in Chemistry from the University of London. Her professional career has included research in industry and academia, also teaching and guiding undergraduates, graduate students and post-doctoral fellows. Teresa has co/authored over 100 scientific publications on therapeutic and/or toxic effects of drugs and chemicals. She has served on many professional committees including grant reviewing Study Sections of the National Institutes of Health. Currently she is a retired research scientist of the Roswell Park Cancer Institute and a Research Professor Emeritus of the State University of New York at Buffalo.

As member of Buffalo Branch of AAUW, Teresa has served several years on the Public Policy Committee while concurrently serving on the Board, first as the International Relations Representative and later as the First Vice-President (Program). She organized a Study/Interest Group on the international status of

women's civil and political rights and initiated the Branch's celebration of the March 8 International Women's Day.

Currently, she and Karen Stephenson are co-chairs of the Public Policy Committee which is working on voter education in relation to the Help America Vote Act (HAVA). The committee promotes civic education by addressing the issues of new voting systems, voter registration, and Kids Voting USA which includes teens voting. Also on the Committee's agenda are voter education on the issues of accessibility and affordability of quality education and retraining/continuing education, which are of vital importance for global competitiveness.

BLACK HISTORY MONTH REPORT: The committee would like to thank all the brave souls who came out in inclement weather on Wednesday, March 14th to the Frank .W. Merriweather, Jr. Public Library to view the screening of *Treemonisha*, fun, frolicking history-making opera by America's foremost ragtime composer, Scott Joplin.

Wednesday, March 21st saw us back at the Merriweather Library for a live production of selections from the HBO Movie *The Water is Wide* performed by Down In My Soul Productions which concluded in a community sing-along led by Joyce Carolyn. This was an opportunity to show AAUW Buffalo Branch to the community - several youths asked for information about Tech Savvy and Sister-to-Sister and adults asked about AAUW membership.

In addition, a raffle was held for LAF featuring a US Post Office Black History tote bag and books, including *The Water is Wide*.

April ¡Adelante! Book/Discussion Group: *Money, A Memoir: Women, Emotions, and Cash* by Liz Perle on April 11th @ 6:00p.m. (see Study Group Announcement.) Our own Buffalo Branch Member Mary J. Christ, Sr. will be our facilitator. Mary J.

Christ, Sr. (nickname Kay) was born Carolyn Cooper, changing her name 25 years ago. Ms. Christ was born in Buffalo, but lived in NYC while studying chemical engineering at Pratt Institute and subsequently resided in Washington, D.C., Cincinnati, OH, and Los Angeles, CA. Among Ms. Christ's notable achievements in her early academic career have been a Regents Scholarship winner, a NACME (National Action Council for Minorities in Engineering) scholar, a Dean's List student, filing for a European patent while a co-op at Procter and Gamble, President of the Pratt Chapter of the Society of Women Engineers and National Chairperson of the National Society of Black Engineers.

A single parent of three young adults, she is currently working on her Ph.D. in Applied Management and Decision Sciences at Walden University and will probably teach at the college level when she finishes her degree. She has worked for several local industries and federal government agencies.

Her area of interest is intellectual property and six-sigma, having made student presentations on these subjects and been published in that field. Ms. Christ owns approximately 20 patent disclosures and eight copyright registrations. She has a B.S. in Legal Information Systems from Empire State College, and an M.S. in International Business from D'Youville and is a notary public. In addition, she writes creative non-fiction and quilts to relax. Her volunteer work in the local community includes having worked with the Harlem Book Fair, the PTA, and as an elections inspector. As a member of the local AAUW Buffalo Branch, and a recent member of the Diversity Advisory Committee, she is looking forward to working with AAUW many years into the future.

REVIEW: In spite of women's supposedly massive buying power and growing presence in Fortune 500 boardrooms, many women are still awfully old-fashioned when it comes to cash. Why do they show so little interest in managing investments? Perle (*When Work Doesn't Work Anymore*) investigates these questions and others in this remarkable sociological study-cum-memoir. Perle also profiles dozens of everyday women, spotlighting the anxiety, embarrassment and guilt money causes them. Commentary from financial experts, sociologists and others helps demonstrate her thesis: women cannot afford to be

ambivalent about money and must learn to separate feelings from finance. Perle's book raises more questions than it answers, which is part of its allure! [Publishers Weekly]

Legal Advocacy Fund Update

The 2007 pins have arrived! Every member donating \$100.00 or more shall receive one. This year, the 2007 AAUW Convention in Phoenix, AZ is highlighting LAF's 25th anniversary. A new 25th anniversary pin was developed for this celebration. It will be awarded to each member donating \$250.00 or more to LAF. Thus, a member donating of \$250.00 or more shall receive BOTH pins. The pins will be available at the NYS convention in April, as well as from the Association.

Any member receiving an Anniversary pin and purchasing a ticket to the LAF awards dinner at the 2007 AAUW Convention in Phoenix, AZ, will have VIP access to meet the honored Speaking Out for Justice awardees, Laura Leedy Gansler and Clara Bingham. They are authors of the book, *Class Action- The Story of Lois Jensen and the Landmark Case that Changed Sexual Harassment Law*. Anniversary pin and ticket purchasers will also meet featured LAF plaintiff Claire Schuster (Schuster v Berea College).

Claire Schuster began working at Berea College in Kentucky as an Assistant Professor of Nursing in 1995. She was awarded tenure in 2001 and promoted to the rank of Associate Professor. When she received her salary letter in May 2002 a salary chart was included. She discovered that her salary was \$5,000 less than the average for other Berea professors at her rank and only \$600 more than the lowest salary within that salary range.

At the same time, she learned that the all-female nursing department had hired its first male faculty member at a salary that exceeded the salaries paid to female nursing faculty members, and that he had been hired directly into the associate level. At the time of his hire, he had significantly less teaching experience and professional experience in comparison to her eight years of teaching and 28 years as a nurse. In addition, he did not have the requisite six years of experience at the assistant professor level or any special qualifications that would have justified his higher rank and salary when compared to the other women faculty.

The nursing faculty expressed their opposition to the Chair of the Nursing Department. Schuster met with the dean in September 2002 to discuss her concerns further. She followed up with a letter summarizing their discussion. He responded via letter at the end of October asking her to wait to address her grievances until spring 2003. In February 2003, Schuster was informed by the dean that no change in salary decisions had been made. In November 2003, Schuster filed a complaint alleging sex discrimination. To date, \$5,000 from LAF has been awarded to her case.

Washington Updates from the Association

Speaker Pelosi Congratulates Mia Hamm and Julie Foudy

House Speaker Nancy Pelosi congratulated Mia Hamm and Julie Foudy on their election to the National Soccer Hall of Fame in a historical year when, for the first time, the entire class selected will be comprised solely of women. Said Speaker Pelosi, "It has been my pleasure to work with Mia and Julie on preserving Title IX – the landmark civil rights law that for nearly 35 years has ensured equal opportunity for women and girls in athletics and education. Title IX has empowered hundreds of thousands of young women on the field and in the classroom to be stronger and bolder through a simple message: your education is crucial and your future is limitless." Foudy was a member of the Commission on Opportunity in Athletics. In 2002, the Bush administration created the

commission to evaluate how current standards governing Title IX's application to athletics should be revised.

First Woman Named Winner of "Nobel Prize in Computing"

For the first time since the annual honor began in 1966, a woman, Frances Allen, is the recipient of the A.M. Turing Award, granted by the Association for Computer Machinery. This award is considered the tech industry's equivalent of a Nobel Prize in computing. Ms. Allen, who began her career as a computer scientist in the 1950s, plans to use the \$100,000 cash prize to establish a fund to help educate young girls in remote areas of the world where the opportunity to go to school is slim or nonexistent. AAUW has a proud tradition of working to encourage girls and women in science, technology, engineering, and mathematics.
