and a responsibility to live deliberately so as to share the lessons I've learned with the people I come in contact with, whether they be my patients, colleagues, or strangers on the street.



A Legacy of Leadership

The "Association of Collegiate Alumnae" was officially organized the following January with 65 founding members who were graduates of eight colleges and universities. By 1884, local branches of the Association were approved and the Buffalo Branch was formed in 1890. The Association of Collegiate Alumnae and the Southern Association of College Women merged to become the American Association of University Women in 1921.

A four year college degree is but the first step. The AAUW also recognizes the need for women to achieve tenure and occupy administrative policy making positions at all levels of higher education. Sadly, these goals have not yet been achieved.

The Legal Advocacy Fund was established in 1981 to aid women who are forced to go to court to seek redress of this egregious situation. Over \$1 million has been granted to more than 70 cases, most of which have been successful, in helping women fight these most difficult battles.

I never imagined that I would spend my time reading depositions and learning the intricacies of the legal system. It was incredibly difficult to become a surgeon during an era when surgery was not commonly chosen by women medical students as a career choice. Being a litigant is even more difficult. The process is long, tortuous and filled with uncertainty. Many times I thought about giving up, however, when the AAUW LAF chose to support my case, I knew that there were a half million highly educated women who were standing behind me and were counting on me. While the amount of money that is granted is modest, the power of the organization and the belief that my case can make a difference is incredibly sustaining during the long and difficult struggle.

I have a difficult time seeing myself as a victim. After all, I am a physician, a healer. I did not recognize myself as a victim until 9 years ago when I was confronted with the unfair treatment that I received at the SUNY Buffalo medical school. I saw the advantages that male colleagues were given at the start of their careers and the opportunities for advancement that they were given preferentially over me and other women. I could not remain silent. I am committed to seeing this through not only for myself but also for those of you who have worked so hard and are committed to the need to have women recognized fairly for the enormous value we must bring to the world."
