# **President's Message**

My girl child must have a voice louder and clearer than mine. She must be able to move with certainty-- shoes on her feet, walking with dreams at her side. The present I have given her is not enough. Her arms are different; they will reach for the sky where freedom lives. - Nepalese mother's poem

I awoke this morning to a very happy sight. My hibiscus is blooming. I love to see the large, milky blooms. It seems that literally overnight the plant decided to demonstrate her full potential.

However, there is a bitter side to this sighting: I associate the hibiscus with the certainty of the onset of fall. It reminds me that summer is almost over and that there is a lot of work to do.

I see a parallel to our mission in AAUW. We dream of and work towards a world of endless opportunities-- a place where girls have the chance to learn and where women are increasingly represented across many diverse fields. And, happily, we have seen the realization of many of those dreams. You may have seen the front page article in *The Buffalo News* discussing the increasingly high performance of girls in school. We see more girls enrolling in all fields and more women enrolling in college.

However, these gains in learning have not translated to equitable earning potential and economic stability. Two recent AAUW research efforts *Beyond the Pay Gap* and *Your Mother's Retirement Security* show this. As my hibiscus shows its lovely blooms today, women still earn about 77 cents for every dollar made by a male counterpart, and women still represent about three-fourths of the elderly poor. Like the Nepalese mother, I wish for something a little *different* for our daughters.

Lilly Ledbetter also found herself staring at a seemingly rosy picture. Retiring as the lone female supervisor in a Goodyear plant, she was quite happy-- until she received an anonymous tip to take a look at her co -workers' salaries. Many of you know of her recent Supreme Court battle, and verdict's sour effect on pay equity cases. Mrs. Ledbetter tells me that *she has a story to tell*. It goes without saying that her fight requires courage and strength in solitude, and it is be-

cause of the anticipated high interest in her visit that we have found it necessary to move the Potluck to accommodate more members and guests. I join you in looking forward to meeting her at our September Potluck dinner.

Please bring a guest to the Potluck as we start the year's discussion. The theme of women's economic equity and security is woven throughout our entire program year. This will give a chance for reflection on the important issue of equity. I also suspect that we will have many opportunities for advocacy and action-- including showing our support for the *Lilly Ledbetter Fair Pay Act*. The summer is almost over.... There's a lot of work to do!

I am so happy to be a part of *this* branch, and I'm looking forward to greeting each of you and your guests at the Potluck!

### **About our Potluck Speaker**

### Supreme Court Plaintiff in Recent Pivotal 5-4 Decision Joins Buffalo Branch on September 10. **Register Today to Attend!**

Lilly Ledbetter will address the Buffalo Branch at the kickoff potluck on September 10. With the July passage of the Lilly Ledbetter Fair Pay Act by the U.S. House of Representatives, Ms. Ledbetter's battle for equity - to the Supreme Court - against one of America's industrial giants is a top topic for office and political debate.

In one of the frequently-occurring narrow decisions, the Supreme Court ruled on May 29 that workers may not sue employers on the basis of discrimination due to unequal pay occurring years earlier.

Lilly Ledbetter was the only female supervisor at a Goodyear tire facility near Birmingham, Alabama. After working nearly twenty years in this position, she learned that she had been consistently paid significantly less than the lowest paid male worker despite having more experience than several of her counterparts. After reviewing the evidence, a jury found that her employer had unlawfully discriminated against her on the basis of sex. This verdict was later overturned, and the Supreme Court concurred that

Ledbetter had waited too long to sue - even though she filed her complaint when she learned of the pay inequity.

In the dissent read aloud by Justice Ginsberg speaking: "In our view, the court does not comprehend, or is indifferent to, the insidious way in which women can be victims of pay discrimination". She followed with commentary that in the ruling the Court had ignored real world employment practices. She urged Congress to correct the Court's mistake.

\_And, Congress responded. Less than one month later, the House Labor committee passed the Act. Another month ferent to, the insidious way in later, the House of Representatives passed the Act. Legislation review is now in the Senate's hands.

Those who are elated by the increased

opportunity for education across our population are somewhat deflated when all workers cannot achieve equitable treatment. Join the branch on September 10 for this very relevant and rewarding discussion, and learn about even more ways that AAUW – nationally and locally - is working in issues of education and equity.

#### **Buffalo Branch Public Policy welcomes biennial emphasis on equity and plans WAGE Club circles**

AAUW-NYS Public Policy Director Nancy Mion, points out in her article on "Moving Forward With Pay Equity" (*Focus*, Spring 2007) that our new mission statement: "AAUW advances equity for women and girls through advocacy, education and research" reinforces our commitment to equity. She states that pay equity is essential and points out that college women 25 and older receive 75% of the pay of their male peers.

At the 2007 NYS Convention a call was issued to launch WAGE Clubs – small groups of women who share personal stories about sex discrimination on the job. They gather information and proceed to work together calling for change of the conditions and for pay equity.

AAUW-NYS already is a founding member of the NYS Pay Equity Coalition (NYSPEC) and has been lobbying for the NYS Fair Pay Act. The NYS Assembly has passed the act every year since 2002 but the State Senate refuses to act on it.

Our Branch's WAGE Club activities could add an important push to our elected legislators from our region and invigorate their support for pay equity for women. This should also help bring about support in the Congress for the Paycheck Fairness Act (H.R. 1338/S.

### Highlights of the May Board Meeting Branch Business

Aurora Hahn, representative from HSBC, reported on our Olga Lindberg investments. Ms Hahn shared that the bank makes contributions to groups concerning education and environmental issues. Leona Barback suggested that members interested can join the finance committee. The committee will get together before meeting with Aurora again at HSBC.

Mary Kellner reported on the N.Y.S. Convention. We earned 15 awards!

Cathy Weiss spoke about the Interclub Council. We will join in September. Cathy is a delegate.

Judy Clare will present the list of new officers at the Annual Luncheon. Marilynn Todd will nominate Lyn McDonald for chairman of Funds For Education from the floor at the luncheon. 766) and the Fair Pay Act (H.R. 2019/S. 1087).

There is a new momentum for such legislation. It stems from the AAUW Educational Foundation research study on the gender pay gap, released in April 2007. This striking report, *Behind the Pay Gap*, found that just one year after college graduation, women earn only 80 percent of what their male counterparts earn. Ten years after graduation, women fall further behind, earning only 69 percent of what men earn. Even after considering hours, occupation, parenthood, and other factors known to affect earnings, the research indicates that one-quarter of the pay gap remains unexplained and is likely due to sex discrimination. Over time, the unexplained portion of the pay gap grows.

AAUW Educational Foundation Research Director Catherine Hill, Ph.D. already testified before a hearing of the U.S. House Committee on Education and Labor concerning the findings of the report, which she coauthored

**Ilene "Joyce" Swartney**, former Buffalo State College faculty member and associate dean, died Sunday, June 3, in Sarasota, Florida at the age of 71. Dr. Swartney earned her Ph.D. in science education/chemistry from the University of Wisconsin. She joined the Buffalo State faculty in 1968, teaching secondary science methods and materials to undergraduates, and a course for graduate students in the elementary school curriculum. She later became the associate dean of the Faculty of Applied Science and Education. She retired in 1994.

Well-known for her educational expertise and an active member of the National Science Teachers Association, the Association for the Education of Teachers of Science, and the American Association of University Women, Dr. Swartney was highly sought after for science workshops and speakers' forums both locally and internationally.

A memorial mass at the Newman Center is planned, tentatively on September 11. A science education scholarship fund is being arranged in Joyce's honor. At this time we have Vanita Evans who has agreed to Chair the Board of Directors and Chandra Banks who will Chair a mentoring event sometime during the following school year.


Thank you for your continuing support. This is a very important event for girls. Anytime you would like to participate on the board or help with the Summit Committee, please let me know.
