# A bit more about our 2009 Woman of Achievement - our own Tamara Brown

A native of Vicksburg, Mississippi, Tamara Brown has been a part of the Western New York community since 1994.

A National Merit Finalist, Tamara graduated from Vicksburg High School with honors. Involvement in many organizations spurred a passion for community efforts and volunteerism, and she spent time during high school in activities at the Mississippi State legislature and in the nation's capital.

Tamara chose to attend Vanderbilt University and completed a double major in biomedical engineering and chemical engineering. While there she served for three years on the school's historic Honor Council and reviewed cases as a part of the Undergraduate Student Conduct Council.

She received her Master of Engineering degree in chemical engineering from the State University of New York at Buffalo . Her studies included a focus in technology management and materials. Her Masters' project focused on the use of "bio dots", synthesized nanomaterials used as biological tags. Tamara also completed a program in small business management from the Center for Entrepreneurship at Canisius College / Whele School of Business.

Professionally, Tamara focuses on emerging technology in the healthcare market. Since moving to Western New York her work has included the design and development of many new medical devices including auto-transfusion systems, orthopedic products, and fiber optic surgical devices. Tamara has led teams in the development of patented medical devices and has contributed to technical publications.

In 2008 she moved to Project Controls team in Praxair's U.S. Project Execution Center - focusing on cost and schedule control for new chemical plant builds and expansions in the United States.

She recently accepted an invitation to serve as an advisory board member of the American Council of Medical Innovation chaired by Congressman Richard Gephardt.

Overwhelmingly, Tamara's community involvement is focused on improving opportunities for women and children. Her AAUW work has included leadership at the branch, state and national levels. At Praxair, she is active in the mentoring program and also leads the Praxair Scientist program. She has also been involved with the Girl Scouts, "Explore and More" NCCA and the National Assn of Negro Business & Professional Women's Clubs, Inc

#### **Booksale Corner**



The 55<sup>th</sup> Scholarship Book Sale will be held in the Office Depot Plaza at 2309 Eggert Rd. Tonawanda. The new site, located at the corner of Sheridan Dr. and Eggert Rd., had its grand opening on April 9 and books are being collected and

sorted there weekdays from 9 a.m. until 5 p.m. with the exception of Tuesdays, when it is open until 8 p.m. Saturday hours are 9 a.m. until noon (except on May 2.) Members are urged to select a work shift from 9 a.m. to 1 p.m. or 1 p.m. to 5 p.m. If you are working during the day, you might be able to help out at the site on Tuesday evenings or Saturday mornings.

Veteran book sale workers describe the site as the most pleasant venue that has been available in recent years. The management even did some of our housework for us—washing windows and scrubbing floors. Stop by for a tour.

The sale will open May 27 and continue through May 31. There is still time for you to sign up to work during the sale. You should have received in the mail a list of jobs and a schedule for volunteers from the

Volunteer Empowerment Committee chairs. (Please note the dates of the sale were incorrect in the first section of the volunteers' blue book.)

The success of the book sale, which is very closely tied to the success of the branch, depends on every member making an effort to help. Your contribution is what makes the difference in the bottom line.

We could also use some of your friends, especially young, able-bodied males wanting to do some body building lifting boxes of books onto the table.

You have a number of choices in how you want to support the sale and it is important to make a decision soon and return your volunteer sheet so schedules can be completed leaving sale workers with one less thing to worry about. All members are invited to an open house at the sale site on Tuesday, May 19, from 4 to 7 p.m. Those attending can check out the facility, look over the collection and buy any of the regularly-priced books (\$1.00 for hard cover and .50 cents for paperbacks). #### **Chamberlin Loan Fund and Funds for Education Update**

The June 1 deadline for one of the Branch's college loans and grants programs is fast approaching. Applications for the Chamberlin Loan Fund and Funds for Education are available through the internet or via snail mail.

Awards are made twice a year to Western New York women and men enrolled in undergraduate or graduate programs in accredited colleges and universities. The last round of applications resulted in six students sharing \$17,000 in interest-free loans and/ or grants.

Awards are given on the basis of academic achievement, financial need, and potential for achieving academic goals. Funds are provided by bequests to the branch and proceeds of the annual Scholarship Book Sale.
