## National Center for Bullying Prevention Comes to UB

The University at Buffalo Graduate School of Education will become the site of a national center for the prevention of bullying, abuse and school violence, thanks to the largest gift in the school's history. The gift from UB alumna Jean M. Alberti, PhD, a clinical and educational psychologist based in Chicago and former local elementary teacher, will establish UB as a proactive national resource on the prevention of bullying and other antisocial behavior among school children.

"We need to change the way people look at this problem to reflect the message that bullying is child abuse by children," said Alberti, who participated in the daylong symposium at UB on the topic. "No one I've ever heard or read about talks about bullying in that language. Until we change the language, we can't change people's understanding of the problem."

At the Saturday annual meeting, the Buffalo Branch of AAUW and the Educational Accounts entity of Buffalo AAUW voted to approve the Plan of Merger and its attached Bylaws proposed by the Governance Committee as announced in the April and May issues of the Advocate. It is now time for the legal process to start. The governance committee will be working with our attorney to file the official papers, etc. Hopefully this will be finalized by the end of the year, but this will require state action (New York State, not NYS AAUW) and we know how everything there is moving along these days. The merger will be invisible to most of the membership but it does mean that our local dues will be deductible on our tax returns and that everything we purchase should be sales-tax-exempt.

The Governance Committee will continue to work to modify the position description manual as well as the board and branch policy book. ### Highlights, NY Convention, April 23 — 25, 2010

The 2010 New York State Convention was held at the Otesaga Resort in Cooperstown, NY over the weekend of 4/23-4/25. The Buffalo branch was represented by five of our members, three of whom serve on the State Board of Directors. Those on the State Board who attended were Ruth Fierro-King, State Treasurer, Lillis McLean, Diversity Director, Betty Preble, Administrative Director. Also attending were Suzanne Oliver, past State President and Anita Kunkle, branch delegate. Anita was appointed to serve as an alternate to the State nominating committee from the 1st District.

Officers presented to serve in 2010 – 2012 were unanimously elected. The positions filled and newly elected State officers are: President, Eileen Hartman, Program V.P., Peggy Kelland and Educational Fund V.P., Lisa Davis Clark.

The Buffalo Branch was recognized for numerous achievements. We are the top branch in NY for LAF contributions, with \$11,344, \$6,200 more than the #2 Westchester branch. We were also recognized as a Star branch for giving \$20/member to LAF. In addition, our branch took 3 baskets to be raffled for LAF. Many of the baskets were outstanding and "shopping" in the LAF basket room was great fun!

We took Silver for overall programming, two notches down from the previously attained platinum. Criteria for improving our standing include strategic planning, programs, membership development and visibility. We do presently excel in monthly programs as we received 1st place for our international program, Progress in Equity: North American Women, held as

part of International Women's Day on March 6.

Yvonne Curry was recognized as our Buffalo branch Emerging Leader. Yvonne was responsible for the diverse set of programs that were held during the year.

We are in the Association Hall of Fame for our participation in the "Every Member Get a Member" campaign begun in July 2006. Since its inception, our branch has recruited 31 new members through the successful efforts of 17 members.

We took an Award of Excellence for our Website and newsletter. Thank you to our editors, Maria Coppola, Betty Preble, Judy Weidemann and Betty Krist.

There were many workshops offered. Of particular interest was one on "Too Sexy Too Soon: How Media Images Affect Young Girls", presented by Deborah Borie. Despite a chilly and overcast weekend, the Otesaga Resort staff provided a beautiful setting for an outstanding assembly of AAUW delegates and officers from throughout the state.
