A VOTE WILL BE TAKEN AT THE MAY ANNUAL MEETING. THE ISSUES AT HAND ARE HERE FOR

YOUR REVIEW.

In last month's Advocate there was mention of a vote that will be taken at the May annual meeting. Most of the board members are familiar with these questions, since they've been discussed all year, but many branch members may not even be aware of the issues at hand. There are two:

- 1. About ten years ago it was recognized that the branch was limited by its lack of a 501(c)(3) tax-exempt status. That status, granted at the Federal level, allows outside contributors to take a tax deduction for sponsoring projects and events. As a result, in November 2002, several branch members worked hard to legally set up a separate entity called the "Educational Accounts and Charitable Projects American Association of University Women Buffalo Branch Inc." It was constructed in such a way that its membership was identical to the membership of the branch itself, so its existence is probably unknown to many of us. However, it does have its own state certificate of incorporation and bylaws. For several reasons, its purposes were stated in specific terms which resulted in unanticipated limitations on its activities.
- The current bylaws of both entities the branch and its "Educational Accounts" – needed some streamlining and changes.
 - a. We were advised that the branch finances should have one person who is responsible for overseeing the various accounts.
 - b. There are some positions whose job functions have changed to the point that a different officer structure is needed. This is partly due to changes which have been made at the national level.
 - c. The presidency has been a one-year job, meaning a new person had to be recruited each year. The proposed bylaws changes

this to a two-year term like other offices.

The proposals which will be put before the memberships are to merge the two entities into one, creating a 501(c)(3) organization known as the Buffalo Branch of AAUW with more general purposes, and to have this single organization adopt a new set of streamlined bylaws. Votes will be taken twice since both the branch and the "Educational Accounts" memberships must vote on them even though it's the same people.

Details of all materials will be available on the branch website — <u>aauw.buffalo.edu</u> (Look at the "branch tools" buttons on the left side of the homepage). These materials will include the old bylaws of both the branch and the "Educational Accounts" entities, the proposed new bylaws, the "plan of merger" and "frequently asked questions". My Tech Savvy Experience, by Judy Malamas

One of the many delights I experienced in volunteering at Tech Savvy this year was being able to hear Elizabeth Casciani, V.P. of Operations and Services for Praxair. Inc. Elizabeth spoke to the adults on the topic, "Life Skills of Problem Solving: Why it's Important." She said she loved coming to Tech Savvy because it was fun and she enjoyed being with those who are "passionate about the success of their students and children." At the end of her talk I was so impressed, I told her she should publish her speech. She handed it to me and said, "You do it."

So here is a condensed version. My apologies to Elizabeth if I misrepresent any of her ideas.

Elizabeth spoke about the importance of encouraging and supporting young women to enter the fields of science and technology. Those areas need diversity and they are very lucrative. Engineers solve problems and in fact that is what life is all about for all of us. We solve problems everyday no matter what we do. We gather data, determine which of many options we'll try first keeping in mind the risk factors and then see what happens. Sometimes this is a very quick process and sometimes a slower more deliberate one. The more experience and information you have, the better you get at making correct decisions.

The more complex the problems, the more creative, inquisitive and analytical one must be. This skill can be learned and you can get better and better at it. Once children acquire problem solving skills they will become more confident and responsible in dealing with everyday situations and with conflicts. This is what builds their selfesteem.

How do you help your child develop these problem solving skills that are so important? Elizabeth went on to mention some ways.

- 1. Model the behavior you want the child to acquire. Example is one of the best ways to teach. Children right through their teens are influenced by what they see you do and say. When you have a conflict with others, how do you work through it together?
- 2. Do you dictate solutions or do you present options?
- 3. If the child develops difficulty while solving a problem, do you bail them out or do you provide encouragement, support and guidance to discover options to weigh and decide?
- 4. Do you try new things yourself and include your kids in these adventures?
- 5. Do you look at failures as part of learning?

Stopping after failing PREVENTS success. For every success there are 10 failures. Trial and error is an ongoing life process where we arrive at successful solutions Children need to practice this skill.

- 6. Do you give credit and praise for TRYING when children fail or do you obsess about the failure?
- 7. Instead of telling children they are smart, compliment the way they tried and persevered until a solution was found.
- 8. Do you encourage hands-on activities such as puzzles and building toys? Legos are not just for boys!
- 9. Do you encourage your children to explore a variety of interests and activities?
- 10. Do you set boundaries?

Other activities that you should model and that children should do that help develop problem solving skills are:

- 1. Playing games and participating in sports.
- 2. Making plans, setting schedules, budgeting expenses.
- 3. Taking things apart and putting them back together.
- 4. Fixing things and building things.
- 5. Working puzzles of all kinds.
- 6. Designing things.
- 7. Providing options and letting them weigh choices.
- 8. Encouraging reading , writing and following directions.
- 9. Encouraging volunteering.
- 10. Stimulating debate and looking at conflicting views.
- 11. Asking, "What would you have done differently?"
- 12. Ask, "If you were in charge what would you do?"
- 13. Playing devil's advocate.

Financially Fit Update—100 Graduates!

Dear Financially Fit Partners,

I wanted to give you an update on where we are with the program and the exciting progress



that we've made so far this year! Last summer, I sought out and identified three women who were active and respected within their ethnic communities. I contracted them to become Community Liaisons within our new program model, to recruit participants who would most benefit from

our services and to teach the classes in culturally relevant ways, directly in the languages we'd identified as the greatest need. After 8 weeks of training, including 14 intensive sessions together, we launched a new 8-week cycle of Financially Fit at the end of September. This included classes in each of these lan-



guages: Arabic, Somali, Burmese, and Karen, a tonal Burmese language (one of the Liaisons is taking on two different language groups from the same country, offering them on different nights). The week before Thanksgiving, we graduated 47

participants, 46 of who opened checking or savings accounts through our program! We conducted another cycle mid-January to mid-March, graduating an additional 53 students, 52 of whom opened bank accounts. The community response for this program has been immense, and we are continuing to offer these language groups in response to the ongoing need. We are planning on launching our next cycle in April and have been accepting referrals from the community.
