

- This was the first meeting of the new organization, American Association of University Women Buffalo Branch Inc.
- Branch members potentially attending the national convention in June include Betty Preble, Suzanne Oliver, Marguerite Collesano, Tamara Brown, and Stacey Johnson.
- The proposed slate of officers was accepted by the Board.
- Cynthia Mehary presented a membership update indicating that four members have joined since the March Board meeting.
- Betty Preble presented position descriptions, which were proposed by the Governance Committee
 and accepted by the Board. The committee proposed a bylaws change: "treasurer for national AAUW
 Funds and other local scholarships" to "Education Accounts and Program Treasurer"
- Diane Silvestro proposed the following Scholarship committee motions, which were accepted by the board: 1. All scholarships for college students should state that applicants must be a resident of or attending school in the 8 counties of Western New York specified. 2. All scholarships should state that an interview may be required for all scholarships/grants/loans.
- Betty Krist made a motion to recommend that Alexa Rommeich and Shilpa Sridhar be awarded the Velma Cobb scholarships. The motion was seconded by Joan Eschner and accepted.
