

# LAF News from the NYS AAUW Convention

The speakers at the LAF Luncheon were Edith Arana, who is a named plaintiff in the anti-discrimination suit Walmart vs. Dukes. Arana had more than 10 years' experience including supervisory management experience before she joined Walmart. During the six years she worked for Walmart, she never rose above a support manager position despite her consistent "above average" or "exceeds expectations" performance reviews. With her was Noreen Farrell, who is the Executive Director of Equal Rights Advocates, a national non-profit law firm that advocates for the civil rights of women and girls. She is serving as counsel in the Dukes vs. Walmart case.

When you hear directly from the litigants and their attorneys about the struggle of women to be financially self-sufficient and are thwarted by their gender – it makes you happy to know that the Buffalo Branch of AAUW was number 1 in contributions in NY AAUW this year with a donation of \$3,678.73! This was a combination of donations given when dues were paid, individual direct donors, and the money from the Carol and Charles Jamieson bequest.

With the help of the branch members who donated five unique purses filled with appropriate "goodies" we helped the purse raffle at convention to be a success. I don't have the exact figure as yet but we raised over \$1500. Thank you to everyone who helped: Joan Trinchera, Laura Wright, Lois Meyer, Susan McClary, Betty Krist, and the Booksale Committee.

Since it is never too early to think about next year, I am already looking for donations for the 2013 NYS AAUW convention to be held in Lake Placid. If we get enough purses donated early, we could have a branch silent auction to raise money for our donation as well as 3 or 4 purses to take to the convention fund raiser.

## COMMUNITY OUTREACH

#### Refugee Needs Forum Update

On March 24<sup>th</sup> I had the pleasure of attending on behalf of AAUW the Refugee Needs Forum sponsored by the Zonta Club. Although the faces of immigrants have changed over the past 50 years, I didn't realize that this would be a trip down memory lane for this proud first generation American. Whereas in the 50s and 60s immigrants still came mainly from Europe, the vast numbers coming to the Buffalo area are from Burma/Myanmar, the Sudan, and Bosnia. These people have come to our country legally and are fleeing oppression. The forum was very worthwhile and provided some eye opening information on the plight of these refugees.

The forum consisted of presentations from the Refugee Relocation non-profits, which included Jewish Family Services, Catholic Charities, and the International Institute. Representatives from Journey's End and Jericho Road, the other two members of the Western New York Refugee Assistance Collaborative (WNYRAC), were unable to attend. Five minute presentations were provided by the women's organizations in attendance. They included the area Zonta Governor, Bonnie Crogan-Mazur, WNY Women's Foundation, Erie County Commission on the Status of Women, the Junior League, Every Woman Opportunity Center, and me wearing two hats as AAUW rep and HUD rep. The forum was lively and representatives were truly dedicated to the cause.

I would like to emphasize that this could be an opportunity for the AAUW membership to expand our networking and collaborative capacity with other women's organizations. Even more significant, this could further offer us additional prospects for making a difference for women in need, either through volunteer work or charitable contributions.

One example of this is a program sponsored by the International Institute called "Buckets of Love." (See <a href="http://www.iibuff.org/clientuploads/Refugee Buckets%20of%20Love.pdf">http://www.iibuff.org/clientuploads/Refugee Buckets%20of%20Love.pdf</a>) Contributions of warm clothing, cleaning supplies, new bedding, personal hygiene products, and school supplies are welcomed for the new arrivals to our country.
