Betty's Rambles

Last month I participated in the voter

registration drive sponsored by the League of Women Voters. What an eye-opener! Although we registered several people that day, two incidents stood out in my mind. One was a young woman who asked, rather hesitantly, if former felons could vote. She didn't think so, but someone had told her she could so she asked. We checked and were delighted to tell her that, at least in New York, once the prison and probation times have been completed she could once again register. She was so excited that her younger life as a "bad girl" (her words) didn't mean that she could never vote again. At the other end of the spectrum was an older woman who answered tersely "no" when I asked if she was registered. I got the same response when I asked if she'd LIKE to register. There's not much one can do – we certainly don't force people to register or to vote – but it was then discouraging to hear her talking with someone else about the problems she was having with "the system." She saw no connection between an imperfect system and her ability to have a voice in changing it.

I hope all our AAUW members have made that connection. The percentage of members overall who are registered is much higher than the national average, but it's not 100%. And even those who are registered may decide on November 6 that "it's too cold today," or "I'm too busy," or "my vote won't matter." Please remember – our foremothers fought long and hard to get us the vote AND there are many times throughout history where ONE vote made the difference. PLEASE VOTE!

"Are Voters Losing their Voice in our Government?"

First, a HUGE thanks to the committee who worked so hard on pulling the day together! Marian Deutschman took on the task of assembling the morning panel, which was outstanding. Sue Oliver worked with the NYS Council on the Humanities to bring Dr. Wagner for the afternoon. Others who should take credit for the wonderful program are Terri Parks, Joyce Bol, Barb Carier, Joan Trinchera, and Betty Preble. Those of you who couldn't attend missed a great day!

Lee Coppola, who moderated the morning panel, did a masterful job of managing the questions for the panel, both his own and those from the audience. He should be invited to moderate the presidential debates. Panel members Craig Bucki, Debora Michaux and Janet Massaro were all knowledgeable and persuasive in their responses and comments.

The afternoon talk, by Dr. Sally Roesch Wagner, gave us more of the details of the life and work of Matilda Joslyn Gage, one of the "triumvirate" leaders of the early suffragists. Members of the audience who had heard Dr. Wagner before and those who had never heard of Ms. Gage both commented on learning more from this talk. Most striking was the variety of causes and beliefs in one person – suffrage, civil rights, religious freedom, and involvement in the Haudenosaunee culture.

Some of the topics which were highlighted in the panel discussion were:

• The voter ID laws, some of which have been upheld and some of which have been stricken down. Many of those which were stricken by the courts will probably be implemented in the long run since the arguments against them were partly based on a lack of time for the government offices and the general public to accommodate the requirements before

- November 6. It was also mentioned that the voter fraud that the ID laws purportedly target is actually less than .00001% of the reported possible fraud. The rest is honest mistakes, most of which would not be addressed by these laws.
- The lack of civics classes in the current high school curriculum was mentioned as a possible cause of low voter participation by younger adults (especially the millennials.) Another factor is the example set by parents children of parents who vote are much more likely to do so themselves.
- The panel was unanimous on declaring that the computer security industry is not ready, yet, to handle computer voting from home units.
- Campaign finance reform MUST happen. When incumbents leave office, they often take with them their treasure chests, which may be disbursed however they choose. County Executive, Joel Giambra took with him over \$1,000,000 which could certainly influence races. There needs to be some method of making independent entities such as the super-PACs accountable limit contributions, limit expenditures, and make contributor names public. Public financing of campaigns remains a possibility.
- Campaigns need to be shorter and voting times need to be longer (early voting, absentee ballots.)
- The current ballots in NYS need to be revised and/or the public needs to be better educated in their use. Two-sided ballots should probably be eliminated.
- Women give less money, but more time, to campaigns. Possible reasons

 frugality and natural organization skills.

November Highlights in US Women's History

Nov 1, 1848 - First medical school for women, the New England Female Medical School, opens; in 1874 it merges with Boston University to become one of the world's first coed medical schools

Nov 8, 1910 - The state of Washington passes a constitutional amendment to permit woman suffrage

Nov 8, 1984 - Dr. Anna L. Fisher, a physician, launches into space as the first American mother and third American woman to fly into space on the shuttle Discovery

Nov 11, 1979 - Bethune Museum and Archives opens in Washington D.C. as a center for African-American women's history, honoring Mary McLeod Bethune

Nov 11, 1993 - The Vietnam Women's Memorial is dedicated in Washington, D.C. Conceived by former army combat nurse Diane Carlson Evans and sculpted by Glenna Goodacre, it honors the 265,000 women who voluntarily served during the Vietnam era

Nov 13, 1938 - Mother Francis Xavier Cabrini is beatified. She is the first American woman citizen to become a saint

Nov 14, 1889 - Journalist Elizabeth Cochran, aka Nellie Bly, sails around the world in 72 days, 6 hours, 11 minutes, and 14 seconds, beating the fictional record set by Phileas Fogg in Jules Verne's Around the World in Eighty Days

Nov 14, 1903 - The U.S. Women's Trade Union League is established

Nov 14, 1946 - Emily Greene Balch, co-founder of the Women's International League for Peace and Freedom, is awarded the Nobel Peace Prize

Nov 28, 1881 - The first organizational meeting is held for the predecessor group to the American Association of University Women (AAUW)
