A REMINDER of AAUW BYLAWS

e all have freedom of speech in this great country! As individuals we enjoy expressing our opinions. As an organization our AAUW bylaws provide guidance on the use of our name.

The national bylaws in Article III. Use of Name Section 1 states "Policies and Programs. The policies and programs of AAUW shall be binding on all members engaged in AAUW activities, and no member shall use the name of AAUW to oppose such policies or programs."

Section 3 of Article III Use of Name states: "Individual freedom of speech. These bylaws shall not abridge the freedom of speech of any AAUW member to speak an opinion in the member's own name."

AAUW has its own policies and programs that we follow as members. Your own opinions are yours to express.

REMEMBERING LYNNE RAPIN

ynne was a very active member of our AAUW branch. When help was needed, she stepped forward. As EAP and Tech Savvy treasurer, she kept the board informed of financial activity for these accounts. She could be found at the book sale, helping to keep books displayed and in any other role that was needed.

Lynne's sudden death last summer saddened all of us. Many asked how they could honor her. Although the branch may not (by national rules) solicit funds for another organization, the board agreed to be a conduit

for donations for A2Empowerment, at https://a2empowerment.org. This nonprofit was co-founded by Lynne's daughter Anne Rapin and Anne Cheung.

Researching this organization online, the mission is stated as: "A2Empowerment is a nonprofit company dedicated to empowering women through education." Qualified young women in Cameroon who are at risk of dropping out of school receive educational scholarships to ensure school completion.

Anne Rapin spoke to our group a few years ago, describing the organization. I met recently with both of these founders and Lynne's other daughter, Beth. They were all ecstatic that our AAUW members might be making donations to this nonprofit.

Freedom & Responsibility

f you're a United States citizen, our Constitution gives you **five freedoms**: freedom of speech, religion, press, assembly and petition. The Free Speech Center at the Middle Tennessee State University elaborates with the following: "Freedom of speech is a core American belief, almost a kind of secular religious tenet, an article of constitutional faith." "Freedom of expression upon public questions is secured by the First Amendment" so that "'debate on public issues should be uninhibited, robust and wide-open." "First Amendment freedoms ring hollow

if government officials can repress expression that they fear will create a disturbance or offend. Unless there is real danger of imminent harm, assembly rights must be respected."

Freedom of choice is the right or ability to choose whatever you want to do or have. The pandemic has limited some of our freedoms. There have been protests

and violent reactions to perceptions of curtailment of freedoms. Professor Borja Santos, MPA/ID, states that freedom is more than simply being able to do what we want. He argues that we must work to ensure that all members of society have the opportunity to satisfy their needs and wants. Freedom should incorporate an expansion of opportunities and capabilities. Philosopher John Rawls, BA/PhD, suggests that if we continue to define freedom as everyone doing what they want, the most vulnerable will continue to suffer through this pandemic. Our pandemic decisions should not be made based on our perceptions of our own low or high risk of infection, but by taking into account everyone's health, economic, and social situation.

Many people are refusing to wear a mask because it's a mandate. A mandate is defined as the authority to carry out a policy that is given by the electorate to a candidate who is victorious in an election. A law and a mandate have the same power to be enforced. Research reveals that political identity may explain some of the mask-related attitudes towards cooperation. Social identity is connected to the visible symbol of the mask itself. There is a strong sense of us-versus-them between mask-

wearers and non-mask wearers that relates to willingness to cooperate.

There are claims that the benefits of the highly restrictive lockdowns that we had during the pandemic may be outweighed by the negative impacts on the economy, social structure, education, and mental health.

For example, there is evidence that the pandemic has been a major threat to the gains women have made in the

workplace. Working mothers took on more childcare responsibilities, forcing them often to reduce their work hours or to leave their jobs during the pandemic. There are simply not enough affordable, high-quality childcare options, which disproportionately harms working mothers, especially those who earn a low or middle income.

The pandemic created a crisis situation, but the lack of support for families was a pre-existing condi-

tion. On the positive side, the post-pandemic work environment may develop more flexible work policy guidelines and some new workplace expectations.

There are many of our own friends and relatives who refuse to be vaccinated. Some people who remain unvaccinated appear to fear the vaccine more than they fear COVID-19. Some resort to making false claims about the dangers of the vaccine. Under the threat of losing their jobs, hundreds of thousands of New Yorkers finally got a COVID-19 vaccine. Teachers, nurses, and home health aides accepted their occupations' mandates. Experts predicted mass resignations but most workers rushed to get inoculated.

Some still believe that mandatory vaccination is a step toward other choices being taken away from us. Peaceful transfer of power is enshrined in our Constitution. Our current distrust of our electoral process, with accusations of fraudulent elections, has led to legislation with a focus on voter suppression in many states, thus making it more difficult to vote. This is to prevent voter fraud that didn't really happen. Now that's a severe loss of freedom!
