

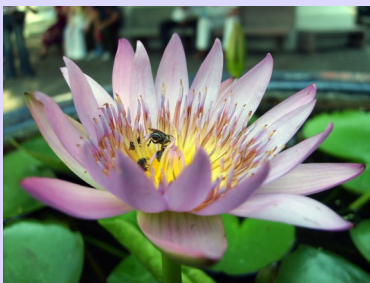

# DID THE REPUBLICANS VOTE FOR THIS CHAOS?

We seem to have the guidelines of Project 2025 on steroids. It's a disgrace, say some of the voters. CEOs and lobbyists are raising concerns regarding the lack of a plan on tariffs and trade wars. Many Americans are feeling the pain of rising unemployment and increasing living costs. Our economic recovery was the envy of the world. Now we seem to face a manufactured recession caused by the disrupter's policies. Congress could vote to end President Trump's tariff power but they gave up their power to do so, leaving Americans to bear the brunt of the fallout. The Department of Government Efficiency (DOGE) is tasked with releasing data on job losses resulting from its search for waste and inefficiency. The president is reshaping reality by hiding data and truth. Meanwhile, federal workers are protesting job cuts and an end to foreign aid programs. People are demanding town meetings with legislators. While Democrats have struggled to organize an effective response, Senator Bernie Sanders has managed to draw large crowds. Democratic Senator and former combat pilot Mark Kelly has found himself at odds with billionaire Elon Musk who called him a traitor after Kelly's Ukraine trip and insistence that Ukraine deserves to have dignity and its land returned.

There is a level of crisis in the country and in the oval office. On February 28, it was coupled with a theatrical performance of strength. Ukrainian President Volodymyr Zelenskyy, as a principled leader trying to save his country, was ambushed in a meeting with President Trump and Vice President J. D. Vance. It is a shame that ruthless people can be shameless. Vance is not a diplomat and Zelenskyy proved that he may be many times the man that Vance is not. Some experts say Trump is selling out to Putin. His negotiating strategy appears to favor Putin. Are we more likely to defend or to abandon Ukraine?

Listening to President Trump, one could conclude that the U.S. is closer to Russia than it is to its NATO allies. Despite Russia's economy being about 1/20 the size of that of the NATO allies, nations like Poland, Estonia and others can no longer rely on American leadership. President Trump appears to behave like a gangster style leader. Canada's accusations of bullying only add to the concerns. Furthermore, Trump's lawsuits with media such as CBS and ABC and his restrictions on other media raise questions about whether his need for loyalty as the #1 reason for choosing some of his cabinet members will extend to censorship of the news. He appears to fire those who put a restraint on his power. He is retaliating against law firms that include lawyers he

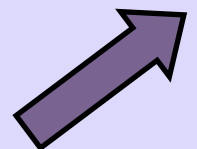
dislikes because they worked against him. Where is the loyalty to democracy? Authoritarianism is first. We may be seeing the last days of NATO because they can't trust U.S. as a partner under current leadership. NATO is convening without the United States.

In the short time since President Trump took the oath of office he's issued over 87 executive orders and numerous executive memos and proclamations that roll back the rights of Americans and violate the constitutional authority of Congress. The Administration has ignored constitutional protections and laws passed by Congress by seeking to end birthright citizenship, dismantling federal agencies and freezing federal funding.

Checks, balances, and the rule of law are fundamental to our democracy, yet Congress has failed to act in response to the Administration's illegal power grabs. A constitutional crisis is unfolding, and Congress' inaction signals its approval of the violation of laws and the Constitution, as well as the Administration's seizure of congressional power. Article I of the Constitution grants Congress all legislative powers and the authority to approve spending in the federal budget. The Democratic playbook for Trump's second term is unclear. Editor of the New Republic Michael Tomasky suggests a more creative mocking of Trump would be effective. Journalist David Weigel suggests that an anti-Trump resistance has come of age. The legal strategy is working. "Democratic attorneys general and the Democracy Forward Coalition of liberal lawyers have been winning in court and throwing up hurdles to the Musk/Trump agenda. Skeptical judges have kept federal workers in their jobs, unfrozen billions of dollars in grants, and preserved birthright citizenship; Democracy's own network of partner organizations has grown from around 180 after the election to more than 400 now." Courts have put stops on Trump. "A failure to act means that Congress is enabling the actions of the executive branch, threatening the rule of law and our Constitution. Every day, congressional inaction jeopardizes our system of checks and balances, our liberties as Americans, and our democracy in its entirety," says Marianne Kligman, community contributor and member of the League of Women Voters of Monmouth County.

It is time for Congress to stand up for the constitution and their constituents.

## DID THE REPUBLICANS VOTE FOR THIS CHAOS? (CONT)

It is time for Congress to resist this power grab and stand in the power that the U.S. Constitution gives them. *Demonstrators have gathered in cities across the U.S.* to protest the Trump administration's early actions. At town halls, Republicans feel the heat from President Trump and Elon Musk's firing and cutting spree. Tesla faces stock market losses and protesters vandalize Tesla cars as backlash to Elon Musk's use of a chainsaw approach to looking for waste and abuse in federal agencies. Educators confirm mounting censorship and government pressure. Elon Musk highlighted the cost of federal spending on entitlement programs, the latest sign of the tech billionaire and presidential adviser's focus to downsize the federal government amid fears of cuts to Social Security, Medicare and Medicaid. Trump says, "We're bringing wealth back to America."

Writing in *The Conversation*, Dr. Thomas Gift of University College London examined the risks associated with Elon Musk's plan to shrink the government and slash federal spending. "The picture of Musk gleefully slicing government jobs could be less a symbol of efficiency, more a symbol of Trump-era hubris," he concluded.

## PUBLIC POLICY FEBRUARY 26 DISCUSSION REVIEW

### 10 Participants:

Discussion of 8 articles submitted by group members (again lively discussion left little time for a You Tube presentation by Professor Richard Wolfe, so it will be discussed at next meeting on **\*Thursday, March 27** at 1 p.m. at same location).

*After significant discussion, we concluded that we are witnessing the rapid start of the dismantling of our democracy without the scrutiny of experts, leading to sacrificing critical life-saving programs and workers. These activities are dangerous for our country, our relationships with other countries, and the livelihoods of Americans.*

### Problems Identified:

Many Americans do not understand the Constitution or the three branches of government and their functions. Our education needs to teach these core beliefs relating them to today's current events.

We are alarmed by the incompetent, erratic behavior of shadow president Elon Musk and his unqualified group of young men looking for better, faster and cheaper government by identifying fraud and abuse with no plan or evidence.

President Trump identifies with autocrats while aspiring to have power like them.

We need to protect our media to have them aggressively determine what's happening. Unfortunately, oligarchs own some of the news sources. The journalists at the Washington Post are in revolt and Zuckerberg has rejected fact-checking. We are the victims surrounded by misinformation, disinformation and continuous lies from our leaders.

We don't know how long it will take for Trump voters to experience "buyer remorse" if inflation and the cost of eggs and coffee increase.

### Potential Actions:

We need to talk to our elected representatives to share our concerns with real stories about their constituents. It is recommended that you write out your statement to be sure that you have addressed all your concerns effectively before contacting the members of Congress.

We must learn to SPEAK OUT effectively. How we achieve this may require some guidance by experts. This could come from academics, debaters, programs, panels etc. How do you make truth more appealing than bizarre lies?

Gather well-researched compelling stories of Americans hurt by the actions over the last 5-6 weeks. Research the conflicts of interest of Musk. We know Trump had 3400 conflicts of interest in his first term using tax-payer funds as he maintained a blur between his business and his presidency. One source says Elon and his businesses have received at least \$38 billion in government contracts, loans, subsidies, and tax credits – *making him one of the greatest beneficiaries of taxpayer money!*
